DESCRIPTION

The Chartered Financial Analyst (CFA) designation is the industry-accepted gold standard for financial analysts. To earn the CFA charter you must pass three very challenging exams. Exam material draws from surveys of practicing analysts and covers 10 major topics. We will look at each of the 10 major topic areas (one per class) and explore the level of understanding that is required to pass the first level exam. We will do applied valuation work as tested on the actual CFA exams. We will highlight study habits of past candidates. We will pay special attention to sub-topics that aren't part of the core RADY MFIN program but that are covered on the CFA exams. Class-size permitting, candidates will get the opportunity to examine tested CFA financial metrics on the 2nd floor Bloomberg terminals.

OBJECTIVES

At the close of this class you will be able to:

- Prepare effectively for the 2018 Level 1 CFA Exam.
- Utilize Bloomberg command <CFAP> for real-time context of CFA material

MATERIALS

Required

This class assumes you are a registered CFA level 1 candidate for the June 2018 or December 2018 exam, and as such will have access to the CFA-required readings. This material can be purchased separately if you are not registered. You will also need a CFA Institute-approved financial calculator (TI BAII or HP12c).

Various 3rd party test preparation materials will be discussed in class some of which can be used in addition to or in replacement of the above mentioned required reading.

COURSE SCHEDULE

Students are expected to pre-read subjects being discussed in the class and to do practice questions on their own in between class. There are graded in-class quizzes but a majority of grade is allocated on class participation. Students should sit for the 2018 Level 1 CFA Exam in June or December.
